

Doug Whitehead, Chairman

Finning International Inc. Success globally and a look into the oilsands"

#### LAST MONTH'S SPEAKER



Dr. Gail Anderson with Art Eberwein

Forensic entomology was first used in China in the 13th century, came into use in Europe in 1850, in Britain in 1930 and came to America in the 1970s. Our speaker, Dr. Gail Anderson, teaches this science and its applications at Simon Fraser University and to police forces across Canada and internationally.

Dr. Anderson fascinated us with slides, case histories and indeed with some humour about the role insects play in providing critical evidence in homicide cases, as well as in cases of abuse of children and of seniors in care facilities. The weapon, the dental records and DNA all are important pieces of evidence in a homicide case but the presence of insects, their type and their location are the evidence that pinpoints the time of death.

There are billions of different flies throughout the world but only certain ones feed on dead animals and again different flies in each of the world's different climate zones. Specific flies will reach a wound in the outdoors within minutes, feed on the bodily fluids and lay their eggs in our natural orifices, and those eggs become maggots with their activities indicating to the trained investigator the likely time of death whether it be within minutes, hours, months or up to 2 years.

When a body is found police rush into the scene in case the person is still alive. If the person is dead, Dr. Anderson, her graduate students and police officers

with years of specialized training enter the crime scene to gather their specific kind of evidence.

In court she testifies only on those issues of which she is certain based on scientific evidence which is now globally recognized. Her evidence has helped to convict many killers but also has cleared innocents who it was clear could not have been there at the time of the murder, even if sometimes they had admitted to the crime

Dr Anderson's evidence as to times of death was admitted in the Picton trial. She suggests that the recent surprising appearance on BC shores of 5 or 6 human feet clad in running shoes is probably the result of drowning over the years and where the separated feet were protected from decay by the shoes.




