Speaker – August 11 Jane Peverett

President and Chief Executive Officer
BC Transmission, Vancouver

*“The challenges of meeting B.C.’s high voltage
electrical transmission needs in the next 10 years”*

Jane is the President and CEO of BC Transmission Corporation (“BCTC”), the crown corporation responsible for the high voltage electricity grid in BC. Jane joined BCTC upon its formation in 2003.

Prior to joining BCTC, Jane worked for Westcoast Energy in a variety of roles, including President of Union Gas Ltd. in Ontario. Jane serves on the board of directors of EnCana Corporation, NW Natural Gas, the BC Business Council and the Electricity Association of Canada.

We will learn more about what BCTC is and its responsibilities for our electricity supply. Jane will describe the corporation’s challenges and commitments and the process it follows in the investigation, planning and development of new transmission line projects.

Jane will speak about BCTC’s current very much in the news Vancouver Island Transmission Reinforcement (“VITR”) project running through Tsawwassen and the need to deal with the expressed concerns and objections of local residents.

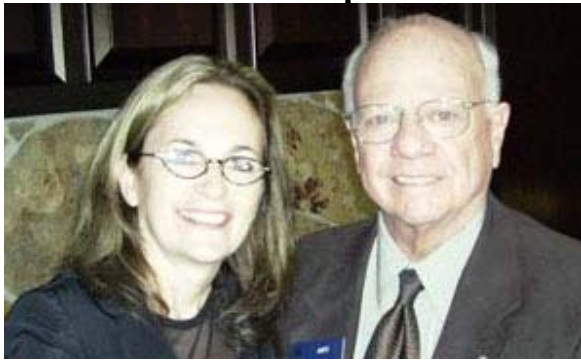

Last Month Speaker

Early in her presentation, Maxine Davis introduced Mrs. Shirley Young from whom we were fortunate to hear first hand how her son, Peter, helped demystify HIV/Aids back in 1992 and how the efforts of this family and many volunteers created the Dr. Peter Foundation which established the Dr. Peter Centre.

Shirley is proud of her son's accomplishment and his being named one of the Greatest British Columbians in the 'Top 10 Crusaders and Reformers', exemplified by those who worked tirelessly to improve our quality of life and who changed the way Canada and the world look at the many challenging issues of our time. Also, his life with HIV/Aids story was the subject of a major award winning documentary presented on CBC TV.

Following Shirley's presentation, Maxine Davis provided us with an up to date report on the Centre. Today the Dr. Peter Centre serves 283 clients, treating 80-90 on an out-patient basis each day with 24 residents in studio suites, and operates with 100 volunteers. The annual cost of operating the Centre is in excess of \$4 million, 85% covered by the BC Government and the balance from donations.

In Dr. Peter's day, 10 to 12 years was the longest anyone survived. That was before the advent of highly active antiretroviral therapies ("HAART"). With the available HAART therapies, a person in their twenties infected today could live into their fifties. However, if anyone needs the therapy treatment and is not on it, he or she may as well be living in Peters' era or in the equivalent of sub-Saharan Africa without access to HIV/Aids treatment.

The lifetime medical cost of treating and managing each new HIV/Aids case in the public health system is

estimated to be \$750,000. The cost of doing so through the Dr. Peter Centre with the relatively inexpensive HAART treatment is less than one-half of that cost, resulting in millions of dollars in savings.

What sets the Dr. Peter Centre apart from other HIV/Aids care facilities in the world is its success with individuals also struggling with mental illness and addiction, particularly the addiction element, and who are living on the street. The Dr. Peter Centre is uniquely successful in that it brings them in from the street to a caring environment that can accommodate behaviours that in other venues would generally be perceived as intolerable.

Data from 2006/07 shows that within one year of admission, Dr. Peter Centre residents reduced their hospital acute bed use by 76% and their hospital emergency department use by 38%. Also, there are indications that if HAART coverage were increased to 90% of infected persons, new infection cases would drop by 54%.

The BC government has recently announced that it will undertake an aggressive new attempt at reaching all persons who should be on HAART and are not, represented mostly by individuals who suffer with mental illness and addiction, and who also often are homeless or in unstable housing. Regardless of the projected savings, that effort recognizes the moral imperative to find ways to get life extending treatment to individuals who should be on it.

The future for the Dr. Peter AIDS Foundation and Dr Peter Centre is now. Their 2008/09 directional interests are twofold: (i) locally, they will expand their capacity to provide more care, with Metro Vancouver a priority, and (ii) they will share their model and experience with similar organizations in Canada and worldwide so they too can provide the Dr. Peter Centre recognized standard of care.

A Q&A period with Maxine Davis and Shirley Young followed the presentation and continued after the meeting. The many thoughtful questions reflected a strong interest in this Foundation's mission of 'COMFORT CARE for people living with HIV/Aids'.

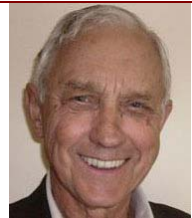
Gordon is married to Elizabeth.
