Monday, October 7th with speaker

Dr. Kris Bulcroft

President and Vice-Chancellor, Capilano University "The Changing Landscape of Post-Secondary Education"

Dr. Bulcroft took the reins as Capilano University's sixth president and second vice-chancellor on August 1, 2010. She brings to the presidency a lifelong commitment to education as a university professor and academic administrator.

Dr. Bulcroft had a distinguished 20-year career at Western Washington University, serving as a professor of sociology as well as vice-provost for undergraduate education - a position she held until 2008 when she joined Franklin College - Switzerland as provost and vice- president for academic affairs.

She holds a BA from Pacific Lutheran University, an MA from Eastern Washington University and a PhD from the University of Minnesota. Her primary field of study is sociology, with emphasis on family life and aging. Kris has published widely on these issues and has worked as a research scientist at the Fred Hutchinson Cancer Research Center in Seattle. She is also a recipient of several Fulbright Awards for research and teaching in Canada and Slovakia, and has served as a reviewer for Fulbright proposals for Central Europe.




Brief Background of a Recent New Member



Denis Crockett (*member since March 2013*) was born in Victoria and has lived in North Vancouver since 1953. After High School he joined the Canadian Army serving in The Regina Rifles from 1942 to 1945. From 1945 to 1950 he obtained a B. Comm. from UBC and an MBA from Ohio State. His initial working career was in the motor carrier industry, first on the regulatory side and later in truck line management and heavy truck sales. A second career of more than 30 years was in planning, design and construction of retail stores and sales and distribution of merchandising equipment and supplies throughout Canada and USA. Outside his business interests, Denis was a volunteer fire fighter and a Coast Guard Auxiliary member.

Last Month Speaker - Dave Inglis

David introduced the problem of investment fraud by telling the story of Fran, a victim of a fraudulent scheme that stripped her of her life's savings. Her trust in the person that referred her to the fraudsters masked the warning signs that led to the disastrous investment. Fran allowed her case to be made public. Typically victims of fraud are too embarrassed by their cupidity to go public; hence fraudsters are not exposed and allowed to continue their nefarious business practices. These perpetrators use telemarketing, religious affiliation and seminars to troll for and entrap potential investors. They use various ploys to mask their outrageous claims, to fog their victims' perceptions and lull them into false expectations. For example, using small numbers such as a 3% return per month, which in fact is promising a return of 36% per year. The victim is rushed to a hasty, ill considered decision to invest as soon as possible. Their victims are often people with money worries and are enticed by what looks like a quick fix. David says that 25% of our provinces population is susceptible to these schemes. In Fran's case 1.7 million dollars was stolen in this one "Ponzi scheme" alone.

The BC Securities Commission (BCSC) use strategies to intercept and disarm these fraudulent schemes before they can inflict damage. However, the perpetrators are very elusive so the BCSC requires that the victims are forthcoming about their experiences in order to track the miscreants at their source. The BCSC is not allied with the police and therefore have greater licence to censure and block the exposed schemes. Many people involved in these scams are not properly licenced to sell securities, even though they claim they are. The Canadian Securities Administrators may be used to check for proper accreditation. They will do background checks to identify previous sanctions as well as any problems with mutual fund salesman groups

or the Investment Research Association (IRA). Always be aware and check the background of the company's officers that you are investing in. Know how that company intends to earn their income and be clear on their methods. If you do not understand, it is probably too obscure for your safe investment. There are five warning signs for a potentially bad investment. Check each of these against any proposal:

- 1. No Risk Investments. The higher the returns, the higher the risk.
- 2. Profit like the Pros. Why would they share their secret?
- 3. Offshore. Tax Free! Now they've got it. Will you get it back?
- 4. Act Now! What? Before you know who they really are?
- 5. Your friends and family can't be wrong. They have worked the room. Watch out!

Do your homework before entrusting funds to an investment advisor. The BCSC is a valuable source of information but the careful reading of complex documents is recommended to understand the constraints for managing the firm's resources.

The BCSC under Civil Law is free to investigate broader issues than the police and can make "freeze orders" that must be responded to or be in contempt of court and face jail time. However, in the end, the BCSC cannot return money that is not there and sadly that is usually the case. All fines and confiscated funds are used for public education. The BCSC relies on public support so if you are aware of suspicious seminars or questionable telemarketing schemes it is to everyone's benefit to keep them informed.
