She is an author and editor of the publication “*Miller Thomson on Estate Planning*” which is updated regularly and is published by Carswell. She is also an editor and author of the BC Probate Practice Manual published by Continuing Legal Education.

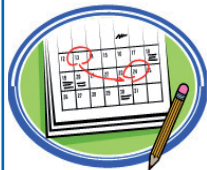
She was a member of the Testate Succession Committee of the Succession Law Reform Project, which reviewed all of the succession laws in British Columbia and resulted in legislation revising those laws as of March 31, 2014. She also served on the British Columbia Law Institute Committee which recommended practices for wills practitioners relating to potential undue influence.

She has been listed in the Lexpert Directory of Leading Lawyers in Canada since 2007 and in Best Lawyers in Canada since 2013 for estate and trust matters. She was appointed Queen’s Counsel in 2014. She has served on a number of not for profit boards and is currently on the Board of the Lions Gate Hospital Foundation.

## Last Month Speaker - Cathy Peters

### **Human Trafficking and Sexual, Youth and Child Exploitation**

Our presenter, Cathy Peters is a parent, concerned citizen and educator who has been raising awareness of this subject for over four years, initially at the Federal government level and now with provincial and Municipal governments. Much of her awareness of the seriousness of the subject arose while she worked with two Federal members of parliament, including West Vancouver's John Weston.

Our presentation began with a video highlighting the problem around the world and what some countries are doing in response. We must realize, however, that this is not a problem that only exists in Europe and Southeast Asia as it is rapidly becoming a major issue in the Lower Mainland and even the North Shore. The rise and use of the internet has provided opportunity for the trafficking to grow and the involvement of criminal gangs has created "hot spots" for exploitation.

We must realize that it is unacceptable for women and children to be bought and sold in a modern and equal society. We were told that we are Mrs. Peters' "army" in this cause and must recognize that each child is one caring and consistent adult away from success.

In her work with Manitoba MP Joy Smith, she met survivors of the sex trade and learned that the solution to the problem is to focus on the source of the problem – men who procure sexual services and those who advertise businesses that open the door to sexual exploitation. Bill C136 The Protection of Communities and Exploited Persons Act, was passed to address this issue.

In her work Mrs. Peters has two goals – education of youth and enforcement of the laws passed to stop exploitation. Her work has prompted her to do numerous school presentations to help educate young people about the dangers and to the Union of BC Municipalities and RCMP detachments to encourage them to enforce the laws that exist.

Human trafficking can be described as a modern form of slavery which is very profitable for those who control it. Where prostitution has been legalized, the demand for exploitation of women and young girls has exploded and is controlled by criminal elements. The trend is to involve girls as young as ten or even younger for Aboriginal girls. Women are moved from poor countries and traditional labour laws cannot control legalized prostitution. In countries where prostitution is legal up to 83 per cent of men buy sex, whereas in countries where it is not legal the number is 7 – 8 per cent.

The solution lies in four areas – awareness, protection, partnerships and prosecution. We need to be aware that this problem exists locally and is growing; are we establishing rules to understand the threat on the internet; government and social service agencies must work together; and the police and courts must uphold the laws that have been passed.

We want our children and grandchildren to grow up in a safe, caring and protective society. "Good men will not exploit and will teach boys to become good men."
